What is economic development? In short, it is finding opportunities and the right investment to fit; however, in a world of opportunities and investors, where does Onoway fit? With limited resources available, which industries should Onoway attract to town? Onoway represents more than just a community. It's a unique collection of resources and opportunities which hold value. A value which fluctuates depending on whom you ask. So, which businesses and industries might value what Onoway has to offer? Town Council recently approved a new economic development strategy for the town. It's a clear direction which allows administration to focus the town's resources on those avenues with the most potential or the greatest impact for the town. This strategy includes an increased emphasis on light commercial, construction, and tourism.

What does this mean? Onoway and the surrounding parts of Lac Ste Anne County have seen 5% population growth over the last two years. The residents of this greater Onoway region represent the customers for the commercial service industry already in Onoway. This includes businesses like grocery stores and restaurants, but also businesses like utility companies which are often more synonymous with light industrial. Currently, Onoway has a range of undeveloped commercial and light industrial properties; however, vacant and imminently developable residential land is a rarer commodity. Most people would agree that housing prices within the Town have increased in the last few years. A sign that the demand for housing in Onoway has outstripped the supply. In the cycle of new residents leading to new services and new services leading to new residents, clearly the bottleneck is finding places for new residents. Near term economic development in Onoway will include a focus on identifying land for residential development and matching it with a suitable local developer. If needed, this could include helping new local developers rise to the occasion. Growth in residential development will also fuel local growth in construction, legal services, banking, and a range of other businesses. More residents are the biggest boost that the local commercial service industry can get and will eventually draw new services to town.

The broader economic development strategy for Onoway includes other elements such as tourism, but they all revolve around the unique resources and opportunities that the region has to offer. Take a moment and think, for yourself ... what does Onoway have to offer? Welcome to economic development.
