Council Meetings & Expenses

- \$175.00 per Council Meeting
- \$100.00 for a Non-Council Meeting up to 4 hours
- \$175.00 for a Non-Council Meeting 4-6 hours
- \$250.00 for a Non-Council Meeting 6 or more hours
- \$250.00 per Month Meeting Expenses for Councillors
- \$400.00 per Month Meeting Expenses for Mayor
- \$.72 cents per Kilometer for meetings outside of Onoway

A Word from the CAO

Municipal government is a calling for many. To contribute, influence and make decisions on the growth and sustainability of your community that is built on the foundation of the past, to provide the direction of the present, and prepare for the future. The time commitment required is varied and challenging at times, however it is very rewarding.

There are initiatives that Administration requires Council's direction for, however, completion of the day-to-day tasks of the municipality are the responsibility of the CAO and the processes are generally set by policy. Council's role is to set the policy and pass Bylaws that align with legislation and provide direction for Administration to implement. It is up to the Chief Administrative Officer, who is the sole employee of Council to implement Council's direction. Staff are the responsibility of the CAO.

One current example of a Council task, is that our infrastructure is outdated and processes need improvement. Council and staff are stretching every dollar to provide services and improve infrastructure. While taxation and grants are the only revenue available, water and sewer utility services are self funded. It is not an easy position for Council when there is much to be done and the process is slow. This isn't localized to our community. This is the case throughout Canada.
